Instructions for use

With this form you apply for a licence for exemption of taxes for removal goods. This licence will permit you to bring removal goods into free circulation with exemption for duties and taxes. It concerns removal goods you wish to import because you are bringing your normal place of residence from a country outside the European Community to the Netherlands or another country within the European Community (EC). Your normal place of residence is where you tend to live.

This license is not valid for the following items:

- Products containing alcohol;
- Tobacco and tobacco products;
- Commercial vehicles;
- Non-portable items for commercial use.

If you want to import a vehicle besides removal goods you can indicate this at question 5. If the means of transport is a motor vehicle you will receive two separate licenses, one license for the removal goods and one for the motor vehicle. Also use this form if you want to report a modification. Then only fill in question 1 and the question(s) for which the data have been modified.

Conditions

To obtain the license, you must meet the following conditions:

- You are transferring your normal place of residence from a country outside the EC to the Netherlands or another country within the EC;
- You have had your normal place of residence during at least twelve months outside the EC:
- The goods belong to your household;
- The goods have been in your possession and use for at least six months.
- The goods have and will be used as furnishings;
- You bring goods into free circulation within twelve months after you transmitted your normal place of residence.
- You will not lend, pledge, let or transfer the goods;

For this a period of twelve months applies after the date on which the goods have been brought into free circulation.

Appendices

Send with your application the following documentation:

- A copy of your passport, possibly including your visa.
- The certificate of registration at city hall; this must proof on which date you have established yourself in the Netherlands or another country within the EC. You can also send a similar document which makes this plausible.
- Two signed packing lists; mention on this list the goods you would like to bring into free circulation;
- (trade)records of all the goods you would like to bring into free circulation.

Please also send, if applicable on your situation, copies of the following documents:

- Your employment contract;
- Your employer's certificate;
- Your labour license;
- Your lease for house or proof of purchase of the house you will live in.

If you want to bring a motor vehicle or another means of transport into free circulation send also copies of:

- The invoice;
- Copy of registration or proof of ownership.
