Dear Mr. Gómez:
With regards to your letter dated May 17 th of this year, I hereby inform you, as you already
know, that this Police Department has been carrying out preventive works in the
importation of household goods
These operations are being carried out throughout the country, specifically in the Customs
of Peñas Blancas, the Customs of Paso Canoas, the Customs of Limón, the Customs of
Airport Santamaría, the Main Customs, and the different Customs Warehouses.
I must also indicate that most irregularities, that is, misclassification, merchandise that is
not included in the Customs Declaration or in the commercial invoice, at the time of picking
up the merchandise by the Customs in the Warehouse. Besides, before paying taxes,
there is no previous packing list to permit a better inspection on the part of Police Officers
or any other official realizing the inspection




These inspections have comprised important importations of household goods on the part

General Customs Bureau and has passed without much delay the controls carried by the
representatives of each Customs, and in this case, by Police officials.
An administrative file has been opened for all those companies that have failed in their
declarations, manifestations, incorrect payment of taxes, or any other incongruence or
irregularity, so that the corresponding Customs Bureau, or otherwise, the General
Customs Bureau, may apply the laws in force
